QUALIFICATIONS Two (2) laps to be run consecutively with the faster lap counting as official qualifying time. The fastest 26 cars are locked in to the Feature Event. The remaining cars will run the qualifying race, transferring the top three (3) finishers to the A-Main (starting in positions 27 - 29), plus one (1) owners provisionals top owner from 2017. Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to buy two tires or change to approved tires for the Feature event. Qualifying race will be run straight up.

FEATURE EVENT – 100 LAPS – 30 Cars Start. Cars will start according to re-draw, followed by remaining transfers from qualifying event and provisionals. Those transferring from the qualifying race will fill the remaining feature positions in the order of the finish from the qualifying race.
