QUALIFICATIONS Two (2) laps to be run consecutively with the faster lap counting as official qualifying time. The fastest 25 cars are locked in to the Feature Event. The remaining cars will run the qualifying race, transferring the top three (3) finishers to the A-Main (starting in positions 26 - 28), plus one (1) owners provisionals, and one (1) past championship drivers provisional – if the champions provisional is not used, it will be awarded as a second owners provisional. Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to change to approved tires for the Feature event. Qualifying race will be run straight up.

FEATURE EVENT – 100 LAPS – 30 Cars Start. Top 8 qualifying cars will start according to redraw, then qualifying, followed by remaining transfers from qualifying race and provisionals.
