The remaining cars will run the qualifying race, transferring the top three (3) finishers to the A-Main (starting in positions 21 – 23), plus one (1) owner's provisional for the highest-ranking owner in the top 20 in championship points whose car did not qualify for the A-Main can use a provisional. Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to use approved tires for the Feature event. All qualifying races will start straight up.
