**QUALIFICATIONS** Two (2) laps to be run consecutively with the faster lap counting as official qualifying time. The fastest 22 cars are locked in to the Feature Event. The remaining cars will run the qualifying race, transferring the top three (3) finishers to the A-Main (starting in positions 23 - 25), plus one (1) owner’s provisional from top owner from 2018. Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to use approved tires for the Feature event. Qualifying race will be run straight up.

**FEATURE EVENT – 127 LAPS – 26 Cars Start.** Top 8 qualifying cars will start according to redraw, then qualifying, followed by remaining transfers from qualifying race and provisionals.
