QUALIFICATIONS Two (2) laps to be run consecutively with the faster lap counting as official qualifying time. After single car qualifying, the top eight cars will redraw for starting positions for the 10 lap Heat Race #1 (immediately after opening ceremonies). The finishing order of Heat Race #1 will determine the top eight starting positions of the "Wild West Shootout – Get It Hot 75". The cars outside the top eight will be split into two heats, odd (Heat 1) and even (Heat 2) 10 lap heats. The finishing order of each heat will determine the balance of the lineup for the "Wild West Shootout – Get It Hot 75". Plus, one (1) owners provisional if needed for current top 20 owner points from 2021, that does not make the top 30 after the heats.

FEATURE EVENT – 75 LAPS – 30 Cars Start. Note: there may be a competition caution within the first 30 laps, and any time after 40 laps of consecutive green flag racing, except in the final 10 laps. \$1,000 to Leader at Lap 27.
