Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to buy or change to approved tires for the Feature event. Qualifying race will be run straight up.

FEATURE EVENT – 200 LAPS – 36 Cars Start. Cars will start according to qualifying times, followed by transfers from qualifying event and provisionals.
